**SYNOPSIS**

ON 7-15-08 AT APPROXIMATELY 0910 HOURS V1 WAS FOUND DECEASED AS A RESULT OF AN APPARENT SELF INFLICTED GUN SHOT WOUND.

**NARRATIVE**

ON 7-15-08 I WAS ASSIGNED TO THE VIOLENT CRIMES UNIT AS A DETECTIVE. THE DUTIES OF THE VIOLENT CRIMES UNIT INCLUDE CONDUCTING CRIMINAL INVESTIGATIONS RELATED TO ALL VIOLENT CRIMES INCLUDING AGGRAVATED ASSAULTS, ROBBERIES, HOMICIDES, AND DEATH INVESTIGATIONS. AT APPROXIMATELY 1000 HOURS I WAS CONTACTED AND ADVISED THAT AN ADULT FEMALE HAD BEEN FOUND DECEASED INSIDE HER RESIDENCE AT 5152 WEST FRIER DRIVE. PRELIMINARY INFORMATION WAS THAT IT APPEARED THE VICTIM HAD SUSTAINED A SELF INFLICTED GUNSHOT WOUND TO THE HEAD. I ARRIVED AT APPROXIMATELY 1010 HOURS TRAVELING EASTBOUND ON FRIER DRIVE WHICH DEAD ENDS IN A CULDESAC. I OBSERVED MEDICAL PERSONNEL AS WELL AS MARKED POLICE UNITS ALREADY ON SCENE.

I CONTACTED GLENDALE FIRE MEDIC DAVID COLSON WHO ADVISED ME THE VICTIM HAD BEEN PRONOUNCED DECEASED AT 1004 HOURS. DAVID WAS THE MEDIC WHO DECLARED THE VICTIM DECEASED. THE VICTIM HAD LEADS ATTACHED TO HER ARMS AND LEGS TO CHECK FOR VITAL SIGNS. OTHER THAN THAT SHE HAD NOT BEEN MOVED AND THE SCENE HAD NOT BEEN DISTURBED. OFFICERS HAGEN #5856 AND BARNES #13299 WERE ON SCENE CONDUCTING SECURITY. THE DOOR TO THE GARAGE WAS OPENED AND I ENTERED THE RESIDENCE THROUGH THIS DOOR.

I WALKED NORTH DOWN A TILE HALLWAY THAT LEADS TO THE KITCHEN AREA IN THE NORTHWEST PORTION OF THE HOME WHERE I CONTACTED A MALE SUBJECT WHO IDENTIFIED HIMSELF AS PAUL HACKER, THE VICTIMS HUSBAND. I COULD SEE THAT PAUL WAS VISIBLY DISTRAUGHT AND I INTRODUCED MYSELF TO HIM AS ONE OF THE DETECTIVES THAT WOULD

BE CONDUCTING THE DEATH INVESTIGATION. I OBTAINED HIS PERSONAL IDENTIFYING INFORMATION AS WELL AS THE VICTIMS. THE VICTIM WAS IDENTIFIED BY AN ARIZONA DRIVERS LICENSE AS GLENDALY VIGOREAUX AND PAUL ADVISED ME SHE GOES BY GLENDA. ONCE DETECTIVE DROBAN ARRIVED I BRIEFED HIM AS TO WHAT HAD OCCURRED UP TO THIS POINT.

I CONTINUED TO SPEAK WITH PAUL REGARDING WHAT HAD TAKEN PLACE. PAUL ADVISED ME HE HAD LEFT THE RESIDENCE AT APPROXIMATELY 0730 HOURS THIS MORNING TO GO TO A MEETING WITH A JOB SEARCH CORPORATION. PAUL ADVISED ME HE HAS BEEN IN THE PROCESS OF STARTING HIS OWN BUSINESS BUT IT HAS BEEN GOING SLOW SO HE WAS IN THE PROCESS OF LOOKING FOR OTHER WORK.

PAUL STATED THAT WHEN HE LEFT THE HOUSE AT AROUND 0730 HOURS V1 GLENDALY WALKED HIM OUT TO HIS CAR, HUGGED AND KISSED HIM GOODBYE LIKE SHE NORMALLY DOES, THEN HE LEFT. PAUL SAID HE RETURNED SOMEWHERE AROUND 0910 HOURS AND DID NOT SEE OR HEAR GLENDALY. WHEN HE SEARCHED THE HOUSE HE FOUND HER LYING ON THE MASTER BATHROOM FLOOR WITH BLOOD COMING FROM HER HEAD. HIS .380 WALTHER PISTOL WAS LYING NEXT TO GLENDALY AND IT APPEARED SHE HAD FATALLY SHOT HERSELF.

PAUL SAID HE WAS EXTREMELY DISTRAUGHT AND DID NOT KNOW WHAT TO DO. HE ACKNOWLEDGED THAT IT TOOK SOME TIME BEFORE HE CALLED POLICE BUT SAID SHE WAS OBVIOUSLY DECEASED AND HE WAS VERY UPSET. I ASKED PAUL ABOUT HIS BACKGROUND WITH GLENDALY. PAUL SAID HE WAS LIVING IN WISCONSIN WHEN HE MET GLENDALY. SHE WAS LIVING NEAR CHICAGO AT THE TIME.

GLENDALY WAS TEACHING A COMPUTER COURSE THAT ONE OF HIS ASSOCIATES WAS ATTENDING AND THEY BEGAN EMAILING BACK AND FORTH. EVENTUALLY GLENDALY MOVED TO WISCONSIN WITH PAUL AND THEY WERE MARRIED APPROXIMATELY 4 YEARS AGO. PAUL SAID HE AND GLENDALY MOVED TO ARIZONA BECAUSE OF A JOB SHE HAD ACCEPTED. PAUL SHOWED ME A BUSINESS CARD FOR A COMPANY CALLED ROUNDPEG THAT GLENDALY HAD BEEN EMPLOYED WITH.

PAUL TOLD ME HE AND GLENDALY OWNED THIS HOME AS WELL AS ANOTHER HOME IN SCOTTSDALE THAT THEY HAD RECENTLY FURNISHED IN AN ATTEMPT TO RENT OUT. PAUL SAID THEY HAVE BEEN TRYING TO RENT THE HOUSE FOR QUITE SOME TIME BUT HAVE NOT BEEN SUCCESSFUL. FOR APPROXIMATELY 6 MONTHS GLENDALY HAS BEEN UNDER AN EXTREME AMOUNT OF STRESS AND HAS NOT BEEN SLEEPING AT ALL. HE ADDED THAT GLENDALY HAD RESIGNED FROM HER JOB OVER THE PHONE ON 7-1-08. SHE HAD THEN COMPLETED RESIGNATION

FORMALLY RESIGNING ON 7-8-08. PAUL SAID THIS WAS STRANGE BECAUSE SHE HAD NEVER TALKED ABOUT RESIGNING WITH HIM AND SHE HAD JUST DECIDED TO DO IT ON HER OWN.

DUE TO HER EXTREME INSOMNIA AND ANXIETY GLENDALY'S DEMEANOR HAD CHANGED OVER THE PAST 6 MONTHS, BUT SHE HAD NEVER MADE THREATS TO END HER LIFE. PAUL SAID GLENDALY HAD BEEN PRESCRIBED DIFFERENT MEDICATIONS TO TRY AND HELP BUT SHE DID NOT LIKE TO TAKE THE PILLS BECAUSE OF THE WAY THEY MADE HER FEEL, ESPECIALLY DURING DAYTIME HOURS. PAUL THEN LEAD ME INTO A LIVING ROOM AREA IN THE SOUTHEAST PORTION OF THE HOUSE WHERE GLENDALY WORKED. ON TOP OF A LAPTOP COMPUTER WAS A NOTEBOOK THAT APPEARED TO BE A DYING DECLARATION.

IT READ "DOCTORS AND FAMILY DISCONNECT ME FROM ANY AND ALL LIFE SUPPORT IF I'M EVER IN A COMA." IT WAS SIGNED GLENDA VIGOREAUX AND BELOW THAT WERE HER INITIALS. THE NOTE WAS DATED 7-15-08. I OBSERVED THAT THE INITIALS ON THIS NOTE APPEARED TO MATCH THE WAY GLENDALY SIGNED HER NAME ON HER ARIZONA DRIVERS LICENSE.

I ASKED PAUL ABOUT THE GUN USED. PAUL TOLD ME IT WAS A WALTHER .380 CALIBER PISTOL THAT BELONGED TO HIM. HE SAID HE USED THE GUN AT THE FIRING RANGE AND IT WAS KEPT IN THE MASTER BEDROOM NIGHTSTAND FOR PROTECTION. I ASKED IF GLENDALY HAD EVER USED THE GUN. PAUL TOLD ME SHE HAD BEEN TO THE FIRING RANGE WITH HIM BEFORE BUT HE DID NOT BELIEVE SHE HAD EVER FIRED IT. PAUL TOLD ME SHE KNEW HOW TO FUNCTION THE WEAPON IN CASE SHE EVER NEEDED TO USE IT FOR PROTECTION THOUGH.

I ASKED PAUL IF HE KEPT THE GUN LOADED AND HE SAID HE DID NOT. HE TOLD ME HE KEPT AN EMPTY MAGAZINE IN THE GUN WHICH WAS IN A HOLSTER. NEXT TO THE HOLSTER PAUL SAID THERE WAS A MAGAZINE WITH WHAT HE BELIEVED TO BE FIVE LIVE ROUNDS IN IT.

A REPRESENTATIVE OF THE GLENDALE POLICE DEPARTMENT'S VICTIMS ASSISTANCE UNIT WAS CONTACTED TO COME AND BE WITH PAUL WHILE WE CONDUCTED OUR INVESTIGATION. ONCE THEY ARRIVED I BEGAN CONDUCTING MY SCENE INVESTIGATION.

THE SCENE IS A SINGLE FAMILY RESIDENCE LOCATED AT 5152 WEST FRIER DRIVE. THE FRONT OF THE RESIDENCE FACES SOUTH. THE NUMBERS "5152" ARE POSTED EAST OF THE GARAGE AFFIXED TO THE STUCCO OF THE HOUSE. THE GARAGE DOOR WAS UP AT THE TIME OF MY ARRIVAL AND I OBSERVED TWO VEHICLES TO BE ON THE PROPERTY. PARKED IN THE DRIVEWAY WAS A GRAY COLORED LEXUS SPORT UTILITY VEHICLE

DISPLAYING ARIZONA LICENSE PLATE . INSIDE THE GARAGE WAS  
A MAROON COLORED MAZDA DISPLAYING ARIZONA LICENSE PLATE

I OBSERVED THAT THE DOOR HANDLE, LOCKS, AND DOOR FRAME  
LEADING FROM THE GARAGE INTO THE RESIDENCE APPEARED TO BE IN  
GOOD WORKING ORDER AND HAD NOT BEEN TAMPERED WITH. I WALKED  
AROUND TO THE FRONT DOOR WHICH WOULD ENTER THE RESIDENCE  
AND OBSERVED A BEIGE COLORED SECURITY SCREEN. THIS DOOR  
APPEARED TO BE IN GOOD WORKING ORDER AS WELL AS THE FRONT  
DOOR LEADING INTO THE RESIDENCE. BOTH DOORS HAD NO DAMAGE TO  
THEM AND HAD NOT BEEN TAMPERED WITH.

AS YOU ENTERED THE FRONT DOOR IT LEAD INTO A LIVING ROOM AREA.  
IN THIS ROOM WAS AN ENTERTAINMENT CENTER WITH A TV AS WELL AS  
A COUCH, A DESK AND A CHAIR. GLENDALY'S LAPTOP COMPUTER WAS  
ON TOP OF THIS DESK AND THAT IS WHERE THE NOTEBOOK WAS  
LOCATED. ALSO ON TOP OF THIS DESK WERE 3 DIFFERENT BOTTLES OF  
VITAMIN SUPPLEMENTS.

TO THE EAST OF THIS LIVING ROOM WAS A BEDROOM. PAUL ADVISED ME  
HE HAD BEEN SLEEPING IN THIS BEDROOM FREQUENTLY BECAUSE OF  
GLENDALY'S INSOMNIA AND IF SHE WAS ABLE TO SLEEP HE DID NOT  
WANT TO DISTURB HER AT ALL. I CHECKED INSIDE OF THIS BEDROOM  
AND NOTHING APPEARED TO BE SUSPICIOUS OR OUT OF ORDER. THERE  
WAS A BATHROOM ATTACHED TO THIS BEDROOM ALSO WHICH  
APPEARED TO BE IN ORDER.

TO THE NORTH OF THE BEDROOM AND LIVING ROOM WAS A FAMILY  
ROOM WHICH OPENED TO THE KITCHEN AREA. THIS FAMILY ROOM WAS  
IN THE NORTH CENTER PORTION OF THE HOUSE. THERE WERE CHAIRS, A  
COUCH, AND A TV IN THIS ROOM ALSO. THERE WAS A DOOR THAT LEADS  
INTO THE BACK YARD. I CHECKED THIS DOOR AND IT HAD NOT BEEN  
TAMPERED WITH AND WAS IN GOOD WORKING ORDER. ADDITIONALLY I  
CHECKED ALL OF THE WINDOWS IN THE RESIDENCE, NONE OF WHICH  
APPEARED TO BE TAMPERED WITH.

THE MASTER BEDROOM WAS IN THE NORTHWEST PORTION OF THE HOME.  
I OBSERVED A BED, AN ARMOIRE, A DRESSER, TWO SETS OF STAND UP  
DRESSER TYPE DRAWERS, AND TWO NIGHTSTANDS. I CHECKED THE  
NIGHTSTAND TO THE WEST OF THE BED AND FOUND THE HOLSTER TO THE  
PISTOL. NEXT TO THE PISTOL WAS AN EMPTY MAGAZINE.

THIS ROOM OPENED UP INTO THE BATHROOM WHERE GLENDALY WAS AT.  
THE DOOR TO THE BATHROOM WAS OPENED. I OBSERVED GLENDALY  
LYING ON HER BACK WITH HER HEAD POINTED TO THE SOUTH. HER FEET

WERE POINTED NORTH. GLENDALY WAS DRESSED IN BLUE PANTS, A WHITE TSHIRT, AND DARK COLORED SOCKS. GLENDALY HAD A RING ON HER LEFT RING FINGER AND A BRACELET ON HER LEFT WRIST. BOTH ARMS WERE OUT TO GLENDALY'S SIDES. HER ARMS WERE BENT AT THE ELBOWS AND WERE BOTH POINTED TO THE SOUTH. GLENDALY'S LEFT LEG WAS PARTIALLY ON TOP OF A LIGHT COLORED BATH MAT. THE REST OF HER BODY WAS RESTING ON THE LIGHT COLORED TILE.

I OBSERVED THE FIREARM TO BE A CHROME COLORED SEMI AUTOMATIC PISTOL. THE HANDLE OF THE GUN WAS POINTING SOUTH AND THE BARREL WAS POINTING EAST. THE GUN HAD A MAGAZINE INSIDE THE MAGAZINE WELL AND THE HAMMER TO THE GUN WAS BACK IN THE COCKED POSITION. TO THE WEST OF GLENDALY'S HEAD THERE WAS A POOL OF BLOOD THAT HAD ACCUMULATED. GLENDALY ALSO HAD BLOOD THAT APPEARED TO HAVE RUN OUT HER MOUTH RUNNING DOWN THE LEFT AND RIGHT SIDES OF HER FACE. THERE WAS ALSO BLOOD RUNNING OUT OF HER NOSE UPWARDS OVER HER RIGHT EYE, AND FOREHEAD. THERE WAS NOT AN OBVIOUS ENTERANCE OR EXIT WOUND AT THIS TIME. ONE SPENT .380 CALIBER CASING WAS LOCATED BETWEEN GLENDALY'S LEGS JUST ABOVE HER SOCK LINE.

I CONDUCTED AN EXAMINATION OF THE WEAPON AND FOUND THE FOLLOWING. ONE LIVE ROUND OF .380 CALIBER AMMUNITION WAS IN THE CHAMBER. THREE LIVE ROUNDS OF .380 CALIBER AMMUNITION WERE LOADED INTO THE MAGAZINE IN THE MAGAZINE WELL. AS PREVIOUSLY MENTIONED ONE SPENT .380 CALIBER CASING WAS LOCATED BETWEEN GLENDALY'S LEGS.

I CHECKED THE REMAINDER OF THE BEDROOM AND BATHROOM AND DID NOT FIND ANYTHING TO BE SUSPICIOUS OR OUT OF ORDER. GLENDALY'S BODY DID NOT APPEAR TO HAVE BEEN MOVED BASED ON THE BLOOD POOLING AND THERE WERE NO SIGNS OF A STRUGGLE OR ANY DEFENSIVE WOUNDS ON HER HANDS OR ARMS. THE MEDICAL EXAMINER'S OFFICE WAS THEN CONTACTED AND ADVISED OF THE SITUATION. WHILE WAITING FOR THEM TO ARRIVE TO CONDUCT THEIR PORTION OF THE INVESTIGATION I WAS ADVISED BY PAUL THAT GLENDALY'S MEDICATIONS WERE IN HER DESK DRAWER NEXT TO WHERE THE NOTE HAD BEEN FOUND. IN THE TOP DRAWER, AND SECOND DRAWER BELOW THAT I LOCATED SEVERAL PRESCRIPTION PILL BOTTLES. ALL OF THESE BOTTLES WERE IN THE NAME GLENDALY VIGOREAUX AND THEY WERE AS FOLLOWS.

ONCE THE MEDICAL EXAMINERS OFFICE ARRIVED I BRIEFED THEM AS TO THE SITUATION. THE INVESTIGATOR ON SCENE WAS INVESTIGATOR KERI REEVES. IN ADDITION TO GLENDALY'S CONDITION IN THE BATHROOM I EXPLAINED ABOUT ALL OF THE MEDICATIONS WHICH WERE LOCATED. THOSE MEDICATIONS WERE TAKEN BY THE MEDICAL EXAMINERS OFFICE. I WAS ADVISED THAT SEVERAL OF THOSE MEDICATIONS WERE ANXIETY RELATED MEDICATIONS AND OVERACTIVE THYROID MEDICATIONS. AFTER COMPLETING THEIR PORTION OF THE INVESTIGATION I WAS ADVISED THAT IT APPEARED GLENDALY HAD SHOT HERSELF THROUGH THE MOUTH AND THE BULLET HAD FRACTURED THE BACK OF HER SKULL. THERE WAS NO EXIT WOUND. GLENDALY WAS SEALED FOR TRANSPORT TO THE MEDICAL EXAMINERS OFFICE. THE SEAL NUMBER UTILIZED WAS 4250318.

AT THE REQUEST OF PAUL A BIOLOGICAL HAZARD CLEAN UP COMPANY WAS CONTACTED AND RESPONDED TO CLEAN UP THE SCENE. I EXPLAINED TO PAUL WHAT WOULD TAKE PLACE FROM THIS POINT FORWARD IN THE INVESTIGATION AND PROVIDED HIM MY BUSINESS CARD TO CONTACT ME WITH ANY QUESTIONS.

I CONTACTED THE MEDICAL EXAMINERS OFFICE ON 7-17-08 AND WAS ADVISED THAT THE AUTOPSY HAD BEEN COMPLETED BY DR. HORN ON 7-16-08. THE CAUSE OF DEATH WAS RULED AS A GUNSHOT WOUND TO THE HEAD, THE MANNER OF DEATH WAS RULED AS A SUICIDE. THIS REPORT WILL BE MAINTAINED FOR INFORMATION PURPOSES ONLY AT THIS TIME.

LOWE ASSISTED WITH SUPPLIES ON SCENE. AT APPROXIMATELY 1:15PM B. LOWE AND MYSELF DEPARTED THE SCENE. ALL PHOTOS WERE DOWNLOADED INTO ID DIGITAL IMAGING SYSTEM BY MYSELF.

I RESPONDED TO 5152 WEST FRIER DRIVE IN REGARDS TO A MALE CALLER (HUSBAND) STATING HE HAD COME HOME AN HOUR AGO AND FOUND HIS WIFE (GLENDA) IN THE MASTER BEDROOM WITH A GUNSHOT WOUND TO THE HEAD AND BELIEVED SHE WAS DEAD.

UPON ENTRY INTO THE RESIDENCE I OBSERVED FIRE PERSONNEL SPEAKING WITH A MALE IN THE KITCHEN IDENTIFIED AS THE HUSBAND. I CONTACTED CAPTAIN PRICE OF GLENDALE FIRE IN THE MASTER BEDROOM, WHO TOLD ME THAT NOTHING IN THE SCENE WAS DISTURBED INCLUDING THE GUN, A SILVER FINISH WITH BLACK HANDLE AUTO, LYING BY THE VICTIM'S HEAD. PRICE TOLD ME HE WAS ON ENGINE 151/B AND HAD ONLY PLACED EKG TYPE PADS ON THE VICTIM TO CONFIRM DEATH.

I OBSERVED THE VICTIM LYING ON HER BACK ON THE BATHROOM TILE FLOOR WITH A LARGE POOL OF BLOOD POOLING AT HER HEAD AND SHOULDER.

AT THIS TIME, A TRAINING UNIT 524B RYAN SMITH #13176 AND HIS TRAINEE ARRIVED IN THE BEDROOM AND I LEFT TO JOIN THE HUSBAND IN THE KITCHEN.

THE HUSBAND ASKED MYSELF AND OFFICER LABOVICK WHO WAS PRESENT, "THIS LOOKS LIKE A SUICIDE TO YOU DOESN'T IT." WHICH WE ADVISED WOULD HAVE TO BE DETERMINED BY INVESTIGATORS.

WHILE WAITING FOR DETECTIVE DARBY AND DROBAN, THE HUSBAND TOLD ME ABOUT REAL ESTATE AND BUSINESS FINANCIAL PROBLEMS THAT THE COUPLE WAS HAVING ALONG WITH A SLEEP DISORDER PROBLEM THE VICTIM HAD BEEN DEALING WITH.

ON 07/15/08 AT APPROXIMATELY 0958 HOURS, I WAS DISPATCHED TO A CALL AT 5152 W FRIER REFERENCE A POSSIBLE SUICIDE.

UPON MY ARRIVAL, I CONTACTED GLENDALE FIRE DEPARTMENT ENGINE 151, SHIFT B WHO TOLD ME THAT (V1) GLENDALY VIGOREAUX WAS FOUND DECEASED AT APPROXIMATELY 1004 HOURS IN THE MASTER BATHROOM. FIRE PERSONNEL ADVISED THAT (IL1) PAUL HACKER, GLENDALY'S HUSBAND, DISCOVERED HER DECEASED IN THE BATHROOM OF THE RESIDENCE APPROXIMATELY ONE HOUR PRIOR TO THE CALL BEING PLACED. PRIOR TO MY ARRIVAL, PAUL HAD ALREADY BEEN REMOVED FROM THE MASTER BEDROOM AND WAS SITTING IN THE RESIDENCE'S LIVING ROOM ADJACENT TO THE MASTER BEDROOM.

I THEN ENTERED THE BEDROOM OF THE RESIDENCE WHICH HAD A BATHROOM CONNECTED ADJACENT TO IT IN THE NORTH CORNER OF THE HOUSE. LYING ON THE BATHROOM FLOOR, I COULD SEE A HISPANIC FEMALE WEARING A WHITE T-SHIRT AND BLUE SWEATPANTS IN A POOL OF BLOOD WITH A SMALL SILVER PISTOL APPROXIMATELY 6 INCHES FROM HER RIGHT HAND. IT APPEARED TO ME THAT GLENDALY HAD INFLICTED A GUNSHOT WOUND TO HER HEAD. FROM THE LEFT CORNER OF HER FACE, SHE HAD BLOOD THAT HAD DRIED RUNNING FROM THE BOTTOM LEFT HAND CORNER OF HER LIP TO THE BOTTOM OF HER CHIN NEXT TO HER EAR. ON JULY 15, 2008 AT APPROXIMATELY 1030 A.M. I RECEIVED A TELEPHONE CALL FROM GLENDALE POLICE SERGEANT, KENT LIVINGSTON, REGARDING A DECEASED PERSON AT 5152 W. FRIER DRIVE. I RESPONDED TO THE SCENE, AND MET WITH FELLOW DETECTIVE TRAVIS DARBY AND OFFICER DEAN HAGEN FOR A BRIEFING. THEY IDENTIFIED THE DECEDENT AS 44 YEAR OLD GLENDALY VIGOREAUX. SHE WAS FOUND DECEASED BY HER HUSBAND, PAUL HACKER, UPON HIS RETURN HOME FROM A JOB INTERVIEW THAT MORNING. THE DECEDENT WAS ON THE MASTER BATHROOM FLOOR FROM AN APPARENT GUNSHOT WOUND TO THE HEAD, AND A HANDGUN LAY NEARBY. HE APPARENTLY WAITED ABOUT AN HOUR BEFORE TELEPHONING POLICE DUE TO BEING DISTRAUGHT. GLENDALE FIRE DEPARTMENT RESPONDED AND CONFIRMED DECEDENT'S STATUS BEFORE MY ARRIVAL. SEE THE RESPONDING OFFICER'S SUPPLEMENTAL REPORTS FOR FURTHER DETAILS. DETECTIVE DARBY TOOK PRIMARY DISPOSITION OF THE INVESTIGATION.

UPON PERUSING THE RESIDENCE I DID NOT NOTICE ANYTHING THAT SUGGESTS SOMEONE CONTRIBUTED TO GLENDALY'S DEMISE. EVERYTHING WITHIN THE RESIDENCE APPEARED ORDERLY, AND THERE WERE NO INDICATIONS OF FORCED ENTRY AT ANY OF THE EXIT POINTS. ON A SPIRAL PAD LYING ATOP THE COMPUTER KEYBOARD IN THE FAMILY ROOM WAS A HANDWRITTEN NOTE SIGNED BY GLENDALY. A COMPARISON OF THE SIGNATURE FROM THE NOTE TO HER DRIVER LICENSE WAS CONSISTENT. IT WAS A DYING DECLARATION REQUESTING SHE NOT BE PLACED ON ANY LIFE SUPPORT. IT WAS PRINTED IN BOLDED LETTERS THAT RESEMBLED SOME HANDWRITING WITHIN THE TABLET. IN FACT, THE TABLET CONTAINED HER PERSONAL THOUGHTS AND ACTIVITIES WITHIN RECENT WEEKS. FROM THE LANGUAGE, I ASCERTAINED THAT SHE WAS FEELING QUITE DESPERATE, EMOTIONAL, AND DEPRESSED ABOUT HERSELF. IT APPEARED SHE HAD SOUGHT ASSISTANCE FOR HER STATE OF MIND, AND WAS POSSIBLY SELF MEDICATING. DETECTIVE DARBY SEIZED THE TABLET AS EVIDENCE.

AT FIRST GLANCE I NOTICED THE DECEDENT WAS LYING ON HER BACK OF THE TILED FLOOR IN THE MASTER BATHROOM. HER LEGS WERE EXTENDED OUT FROM HER BODY IN A NORTHERLY DIRECTION, AND BOTH HANDS RESTED NEAR HER HEAD. NEAR HER RIGHT HAND WAS A SMALL .380 CALIBER, SEMI-AUTOMATIC HANDGUN WITH A COCKED HAMMER. A CLOSE EXAMINATION OF THE FIREARM REVEALED

MINUTE BLOOD SPATTER ON THE END OF THE BARREL. SIMILARLY, I NOTICED OBVIOUS GUNPOWDER STIPPLING ON HER RIGHT HAND AND THUMB. AROUND HER HEAD WAS A CONSIDERABLE AMOUNT OF BLOOD THAT APPEARED TO HAVE BEEN ASPIRATED FROM HER MOUTH. THIS WAS PARTICULARLY OBVIOUS BY THE DRIED BLOOD EXTENDING FROM THE CORNERS OF HER MOUTH, DOWN THE SIDES OF HER FACE. THERE WAS ALSO A SMALL AMOUNT OF BLOOD SPATTER ON HER RIGHT CHIN. I DID NOT NOTICE ANY EXTERNAL TRAUMA TO HER HEAD OR BODY. ALTERNATIVELY, THE INTERIOR OF HER MOUTH WAS QUITE BLOODIED WITH REMARKABLE TRAUMA.

FROM MY OBSERVATIONS, I SURMISED THAT GLENDALY LIKELY SHOT HERSELF WITH THE HANDGUN IN THE MOUTH WITH HER RIGHT HAND WHILE SEATED ON THE BATHROOM FLOOR. THERE IS NOTHING REMARKABLE ABOUT HER CONDITION TO SUGGEST SOMEONE ELSE IS RESPONSIBLE FOR HER DEMISE. THE STIPPLING ON HER RIGHT THUMB IS CONSISTENT WITH THE BLOOD SPATTER ON HER CHIN, INDICATING THAT SHE LIKELY USED THAT HAND TO PULL THE TRIGGER. SIMILARLY, THE MINUTE SPATTER ON THE GUN IS CONSISTENT WITH A SELF INFLICTED GUNSHOT WOUND TO THE INSIDE OF THE MOUTH. THUS, MY INVOLVEMENT IN THIS MATTER IS CONCLUDED AT THIS TIME. SEE DETECTIVE DARBY'S OFFENSE REPORT FOR FURTHER DETAILS.
